Nursery the sum of LM35 (thirty five Malta Lira) of Children age 5 to 10 and Lm40.00 (Forty Malta Lira) for children age 11 to 16 upon submission of this registration form representing one year's registration fee (cheque to be made payable to Sliema Wanderers F.C. Nursery);
2. Documents to be supplied together with this registration form:
 - a. One (1) original birth certificate issued from the Public Registry;
 - b. Four (4) coloured passport sized photographs;
 - c. The official release form in the event that the child being registered was previously registered with another nursery.
 - d. Medical Certificate attesting the sound medical condition of the child and his fitness to undertake the physical training as deemed necessary by the coaches of the Sliema Wanderers F.C. Nursery and to participate in football matches;
3. The parents and legal guardians, whose signature appears overleaf, hereby declare that their son/daughter is of sound medical health and is fit to undertake the physical training as deemed necessary by the coaches of the Sliema Wanderers F.C. Nursery and to participate in football matches. To this effect the parents and legal guardians have submitted a medical certificate certifying the soundness of the medical health of their son/daughter and his/her fitness to undertake the said physical training and participation in football matches;
4. Notwithstanding the terms of the previous clause the parents and legal guardians, whose signature appears overleaf, hereby unconditionally release the Sliema Wanderers F.C. Nursery and its officials and appointees from all and any responsibility in relation to any injury, health failure, death and / or loss to their son/daughter or their property whilst their son is participating in any training, match and / or activity organized by the Sliema Wanderers F.C. Nursery;
5. The parents and legal guardians, whose signature appears overleaf, hereby expressly authorize the Sliema Wanderers F.C. Nursery, its officials and appointees to instruct, as the latter deem necessary, medical intervention, of whatever nature, on their son/daughter in the event of health failure and / or injury, without incurring any liability of whatever nature;
6. We the Data Subjects, whose signature appears overleaf, on our behalf and on behalf of our minor child, whose name appears overleaf, hereby give our unambiguous, explicit and unconditional consent to:
